Ottawa County Board of Commissioner's Minutes October 2, 2023

The Board of County Commissioners met in regular session in Suite 201 at the Ottawa County Courthouse.

Those present were:

First District Commissioner Dawn Wolf, Third District Commissioner D. D. Malmberg Michelle Campbell, Human Resources JoDee Copple, County Treasurer/Payroll Cler Heather Maddox, County Clerk

Commissioner Wolf called the meeting to order at 8:00 am and led the group in opening prayer, followed by the flag salute.

Karl Leech came into the commission meeting.

On motion by Commissioner Wolf, seconded by Commissioner Malmberg, by unanimous vote the Board approved to claim October as Down Syndrome Awareness month.

County Departments:

Human Resources

Malmberg talked with Michelle Campbell about insurance questions.

Malmberg also discussed old business with Campbell about the server for the Road and Bridge department and the Noxious Weed department.

Rick Shupe came into the commission meeting.

Malmberg would like to discuss with previous IT and see if a server was in the budget to purchase for the 2023 year or not. Campbell discussed with commission about upcoming holidays and asked if staff can participate. Commission approved.

Malmberg discussed the new water cooler in the breakroom. Malmberg said she was not informed of an additional water cooler in the breakroom. She doesn't think it is necessary because there is one around the corner in the hall.

Road and Bridge

Chris Smith and Joe Mullen came into the meeting and asked the commission to sign off on a right of way permit. Commission signed off. Smith presented the commission with sand sealing Wells Rd (Doering Curve) and not overlaying the road that APAC just put down. Commission asked if sand seal would work. Smith said yes, in 5 years the department will have to chip seal the whole road. Malmberg asked why you would have to do that in 5 years. Smith said that all roads are on rotation and that is when Wells Rd would be up for resurfacing. On motion by Commissioner Malmberg, seconded by Commissioner Wolf, by unanimous vote the Board approved to sand seal over the Doering Curve repair in the amount of \$5,444, work being done with County employees.

On motion by Commissioner Malmberg, seconded by Commissioner Wolf, by unanimous vote the Board approved to accept payroll for the month of September.

Attorney

Richard Buck came into the meeting and requested an executive session.

On a motion by Commissioner Wolf seconded by Commissioner Malmberg, by unanimous vote the Board approved a 10-minute executive session for Attorney-Client Privilege to discuss confidential data including Wolf, Malmberg and Richard Buck. To return at 9:45am. No decision was made.

Jerry Ayers came into the commission meeting.

Malmberg discussed with Buck about the past due Housing Authority solid waste fees. The commission has discussed with the Solid Waste board about this issue. Buck said he has seen this and is aware. Buck will look into this and see what more he can do.

Michelle Callum came into the commission meeting to give an update about Community Corrections. Callum discussed a new addition to the office, a service dog. Callum discussed an upcoming conference with the commission, this is a drug court conference that is presented by Paul Cary and Officer Jermaine Galloway. Michelle Callum left the meeting.
