# Ottawa County Board of Commissioner's Minutes June 17, 2024

The Board of County Commissioners met in regular session in Suite 201 at the Ottawa County Courthouse.

Commissioner Wolf called the meeting to order at 8:00 a.m. and led the group in opening prayer, followed by the flag salute.

Commission attended the pinning of Deputy Dayton Rindt, Deputy Pelton Smalls, and Undersheriff Jerry Ziolkowski. Sheriff Thornton recognized Sheriff Office staff for their hard work and stepping up the last few months.

Commission went over invoices.

Robert Boss and Brian Breese came into the meeting at 8:37 a.m. The Bennington Fire Department would like to ask the commission for a total of \$248,000 for their 2025 budget. Malmberg asked what kind of big purchases they have in mind for 2025. Chief Breese said they have wants and needs but they have things that are outdated like the jaws of life. Brandon Copple and Richard Buck came into the meeting at 8:46 a.m. Chief Breese said they are looking at getting an air dispenser to fill air tanks, this would save them from having to go to Salina. Wolf asked about turn over and how many active volunteers they have. Chief Breese said there are 40+ on the team. Wolf said they have talked to Minneapolis, and they have been toning down the volunteers and it saves them money on disability insurance. Chief Breese said that the average age of volunteers are in their sixties. The volunteers have requirements they have to follow, the Fire Department doesn't let anyone on. Malmberg asked if any of this money is for the EMS side. Chief Breese said no the EMS will present their own budget. Commission asked Breese if he could get the commission a breakdown of funds they are expecting to spend for the 2025 budget year, they would like to see specific line items. Chief said they could do that.

Breese and Boss left the meeting at 8:59 a.m.

Julie Yarmer with Freedom Claims Management came into the meeting at 9:00 a.m. JoDee Copple, Richard Buck and Michelle Campbell came into the meeting at 9:02 a.m.

Julie gave a review of the insurance from January 2024 through May 2024. The group discussed different ways of doing health insurance for 2025.
