# Ottawa County Board of Commissioner's Minutes May 6, 2024

The Board of County Commissioners met in regular session in Suite 201 at the Ottawa County Courthouse.

#### Those present were:

First District Commissioner Dawn Wolf Second District Commissioner Scott Mortimer Third District Commissioner D. D. Malmberg Brandon Copple JoDee Copple, Treasurer Heather Maddox, County Clerk Stephanie Watkins, Deputy Clerk

Commissioner Wolf called the meeting to order at 8:00 am and led the group in opening prayer, followed by the flag salute.

### **County Departments:**

#### Sheriff

Prisoner count Ottawa County 4.

#### Zoning

Truette McQueen asked the commission to appoint Joshua Hulse, Gary Keating, and Robert Jilka to the Zoning board again.

On motion by Commissioner Malmberg, seconded by Commissioner Mortimer, by unanimous vote the Board approved to reappoint Joshua Hulse, Gary Keating, and Robert Jilka for another 3-year term on the Zoning board.

Truette asked the commission if he could hire for a third position in the Appraiser's Office. Commissioners asked if it was in his budget. This will bring his employees to three and a half employees.

Richard Buck, Attorney came into the meeting at 8:17a.m. Chris Smith and Joe Mullen came into the meeting at 8:19a.m.

#### **Road and Bridge**

Chris Smith, discussed with the commission about an easement right of way in Wells.

#### **County Counselor**

Buck discussed the updated burn resolution with the commissioners.

On motion by Commissioner Malmberg, seconded by Commissioner Wolf, by unanimous vote the Board approved Resolution 24-08 establishing regulations, required procedures and penalties for open burning within Ottawa County. This resolution will repeal former Resolution 16-24.

Hannah Bett, Deputy Administrator from Saline County on behalf of Saline County Sanitarian came into the meeting. Bett wanted to make sure the commission knew that the Legislature passed a law that each county can appoint their own coroner. Dr. Dupy has been the shared coroner between Ottawa and Saline County. Bett stated that she talked with Dupy and he only has around 10-15 people in Ottawa county per year, so he would be willing to continue this service with Ottawa County. Malmberg would like to see if there is someone in county that would like to be the coroner. Mortimer will reach out to Todd Wilson and see if he knows anyone. Bett discussed with the commissioners about the sanitarian budget. Bett said that Ottawa county pays Saline County \$12,000 a year right now. Bett is proposing Ottawa County pay a percentage of time they spend in Ottawa County and divide that by the time they spend in all counites served. Malmberg asked what does the sanitarian department budget now? Bett said the budget is set at \$186,144 and Saline County does not see that they will lower the budget. Bett said this is a shared district with Lincoln, Ottawa, and Ellsworth counties. Bett said that Ellsworth is paying a portion in the amount of \$12,500 and Lincoln is paying a portion in the amount of \$13,500. Wolf asked what the proposal is for Ottawa County. The new fee for Ottawa County would be \$58,000 minus the fees collected up from \$12,000. Bett said she would like to subtract the fees they collect for permits in the county and update the commissioners on a final number. Bett will email the proposal to the commission.

#### Clerk

On a motion by Commissioner Malmberg, seconded by Commissioner Mortimer, by unanimous vote the Board approved the claims as presented.

On a motion by Commissioner Malmberg, seconded by Commissioner Mortimer, by unanimous vote the Board approved the April 29th, 2024 minutes as corrected.
