The Board of County Commissioners met in regular session in Suite 201 at the Ottawa County Courthouse.

Road and Bridge

Chris Smith Road and Bridge Administrator and Joe Mullen Road Supervisor came into the commission meeting. Smith gave Wolf sealed Bridge inspections from Kirkham Michael \$34,000. Wolf opened sealed bid from BG Consultants \$27,500.

On motion by Commissioner Malmberg, seconded by Commissioner Wolf, by unanimous vote the Board approved to accept the bid from BG Consulting for the bridge inspection including 250 bridges and a critical bridge for the total of \$27,500.

Smith asked the commission if he could send Road and Bridge mechanics to electrical class, emissions, and SIS class through CAT training. Commission said yes it would be good for them to have.

Malmberg asked Smith how salt and sand supplies are. Smith said they just got some in and they are good. Smith said the weed department is going with the sign crew and making signs.

Smith and Mullen left the meeting.

Yanna Ross, Risk Management with KCamp came into the meeting. Ross came to present a KCamp award for loss, Ottawa County has had a 10% loss ratio. This means the county hasn't had very many claims with KCamp insurance. Ross left the meeting.
