The Board of Commissioners met in regular session with Commissioner Kathy M Luthi, Commissioner James P Kay, Commissioner Ray McGavran, and County Clerk Mary Arganbright.

Commissioner Luthi opened the meeting with the flag salute and prayer.

The official minutes of April 16, 2012, were approved and signed.

An abatement was signed.

Randy Dick, Kaw Valley Insurance, met with the board and gave them an update on health insurance for the first three months.

Commissioner Kay moved to reappoint Tom McGavran to the Ottawa County Health Center Board, effective January 1, 2011. Commissioner McGavran seconded. Motion carried.

Commissioner Kay moved to go into executive session at 9:00 a.m. for ten minutes to discuss non-elected personnel. Commissioner McGavran seconded. Motion carried. Those present were the commissioners, John Copple, Highway Administrator, and Kenny Wilcox, Road Foreman. They returned to regular session at 9:10 a.m. No decision was made. John reported on what crews were doing. John said the overlay project would be starting May 7.

Peg Condray, Minneapolis, stopped in as a concerned citizen of the jailbreak last week. She said she remembered when the jail was proposed to be built, the public was told that hardened criminals would not be housed there. The commissioners thanked Peg for coming in and talking to them.

Commissioner McGavran moved to go into executive session at 9:30 a.m. for ten minutes for non-elected personnel. Commissioner Kay seconded. Motion carried. Those present were the commissioners and Betty Mick, County Attorney. They returned to

regular session at 9:40 a.m. No decision was made. Commissioner McGavran moved to go into executive session at 9:43 a.m. for fifteen minutes to discuss attorney/client matters. Commissioner Kay seconded. Motion carried. Those present were the commissioners and Betty Mick, County Attorney. They returned to regular session at 9:58 a.m. Betty will be present at 10:30 a.m. when the press is here.

Keith Coleman, Sheriff, gave prisoner count of Sedgwick County 20, City of Minneapolis 1, Saline County 18, and Cloud County 1. Keith said that Glass Services will be here today to fix the front door. Commissioner McGavran moved to go into executive session at 10:02 a.m. for three minutes to discuss non-elected personnel. Commissioner Kay seconded. Motion carried. Those present were the commissioners, Keith, and Mary Arganbright, County Clerk. They returned to regular session at 10:05 a.m. No decision was made. Commissioner McGavran moved to go into executive session at 10:05 a.m. for three minutes to discuss non-elected personnel. Commissioner Kay seconded. Motion carried. Those present were the commissioners, Keith, and Mary Arganbright, County Clerk. They returned to regular session at 10:08 a.m. No decision was made. John Wilson, Minneapolis Messenger, Tim Unruh, and Tom Dorsey, Salina Journal, joined the commissioners, along with Betty Mick, County Attorney. John asked if there was anything that was going to be changed since the jailbreak last week. Commissioner Luthi said that she has no answers yet, as they were just briefed minutes ago. Betty indicated that the commissioners have budgetary control over the sheriff, and nothing else. This has been the commissioners first chance to talk to the Sheriff, and the commissioners need a chance to put the facts together. John asked when was the decision made to take State prisoners. Commissioner Luthi said a contract was made June 2011, and the first prisoners were taken January 2012. John asked about screening

of inmates and how they got through the system. Commissioner Luthi said that she wasn't sure, that was a question for the Sheriff. John asked the future of the jail and inmates taken in. The commissioners said that it's the Sheriff's overall decision, but that they hoped to be in on the decision. Tim asked what the commissioners concern was. Commissioner Luthi said the safety and protection of all the employees and citizens of the county. (More specific details of reporters questions can be found in the articles they write).

At 1:00 p.m., the commissioners held the Lakeview hearing on a proposed alleys and streets vacation by Don Mutschler. Those present were Betty Mick, County Attorney, Kent and Marcia Carlson, Don Mutschler, Jacob and Sue Kelley, Billy and Bonnie Gardner, and Ralph and Peggy Krummen. Don said that he is the petitioner for the vacation, and would like to hear from the rest. Mr. Gardner said that they just wondered what will happen to the ground. Betty explained that the county is just vacating their right to use the easements. Mr. Krummen thinks that he might be loosing footage. Betty explained that she didn't think so, but possibly the fence that is up needs to be surveyed. The Kelley's said that their property has already been vacated. Kent said that he has no concern on the alleys, just the access to his pasture on the north side. Kent said Don and him have talked and they have come to a understanding, by handshake. The commissioners thanked Don for all the work he has done on the legal descriptions and having the surveying done. Commissioner McGavran moved to pass Resolution 12-16, declaring the following various alleys and streets vacated:

A parcel of land being a 20 foot Alley right-of-way lying adjacent to the West line of Lots Five(5), Six(6), Seven(7), and Eight(8) in Block Two(2) in the Original Plat of Townsite of Lakeview, Ottawa County, Kansas more particularly described as follows:
