Commissioner Mortimer seconded. Motion carried, 3-0.

Marie Ballou, Emergency Management Coordinator, brought in the SPARK funding monthly report for the commissioners to review and sign. Josh Brown, Custodian, was present also. Commissioner Wolf thanked Josh for what he does for the courthouse. Commissioner Wolf did not feel they gave him much direction on the job when he took over.
