The Board of Commissioners met in regular session with Commissioner Kathy M Luthi, Commissioner James P Kay, Commissioner Ray McGavran and County Clerk Mary Arganbright.

Commissioner Luthi opened the meeting with the flag salute and prayer.

John Wilson, Minneapolis Messenger, was an observer.

Jason Parks, Candidate for Ottawa County Attorney, was an observer.

Justin Ferrell, KCAMP, county's liability insurance attorney, was present. John Wilson asked questions pertaining to the current county attorney, in which the commissioners answered.

Tammy Schmidt, USD #239, came in and discussed Red Ribbon Week, October 23-31, 2012. Commissioner McGavran moved to donate \$200 from the Drug & Alcohol Fund for Red Ribbon Week. Commissioner Kay seconded. Motion carried.

Betty Mick, County Attorney met with the commissioners. Others present were John Wilson, Minneapolis Messenger, and Justin Ferrell, KCAMP. The commissioners asked Betty her level of commitment for the remainder of her term. Betty said that she has been back since September 1, 2012. Betty said that she has always intended to fulfill her term.

Phil Aumick, Economic Development Director, came in and his pay will be adjusted for when the commissioners raised his hours to 32 hours per week.
