The commissioners signed Resolution 09-23, appointing Richard Buck, a qualified, licensed, and practicing attorney for the State of Kansas, to act on behalf of the Ottawa County Attorney on two cases.

Commissioner McGavran signed the Retail Dealer's 2010 License for Cereal Malt Beverages for Alice Jo Campbell, d/b/a The Virginian.

Kenny Baccus, Noxious Weed Administrator, met with the commissioners to give his recommendation for the utility vehicle. Kenny went through each quote pros and cons. After discussion, it was decided for Kenny to go back to Sellers Equipment and get a quote without the snow blade.

Vouchers were approved.

Added's and abatement's were approved.

John Copple, Highway Administrator, reported on what crews were doing.

Commissioner Kay moved to adopt the amended and restated bylaws and interlocal cooperation agreement for the Kansas County Association Multiline Pool. Commissioner Luthi seconded. Motion carried. Resolution 09-24, to participate in and form a municipal self-insurance pool for the insurance coverage for certain liabilities.

Commissioner McGavran signed the Lease-Purchase Agreement with Bennington State Bank for the two 2010 Motorgraders.

Commissioner Luthi moved to go into executive session at 9:30 a.m. for twenty minutes to discuss confidential data. Commissioner Kay seconded. Motion carried. Those present were the commissioners, Sandy Cline, Health/Aging Department, and Joy Johnson, Ottawa County Health Center. They returned to regular session at 9:50 a.m. The decision was for Sandy and Joy to continue working on negotiations for a joint venture, and report back to the commissioners.
