Vouchers were approved.

Commissioner Luthi moved to appoint Kyle Black as Bennington Township Clerk to replace Gail Appleby. Commissioner Brumbaugh seconded. Motion carried, 3-0. Commissioner Luthi moved to appoint Tom Zorn as Ottawa Township Trustee to replace Ken White. Commissioner Brumbaugh seconded. Motion carried, 3-0. Commissioner Luthi moved to appoint Kevin Watts as Lincoln Township Clerk to replace Matt Hettenbach. Commissioner Brumbaugh seconded. Motion carried, 3-0.

Commissioner Brumbaugh moved to go into executive session at 8:06 a.m. for ten minutes to discuss non-elected personnel to protect the privacy of the employee. Commissioner Luthi seconded. Motion carried, 3-0. Those present were the commissioners and Mary Arganbright, County Clerk. They returned to regular session at 8:16 a.m. No decision was made.

Tanya Paul, DVACK Outreach Specialist, met with the commissioners and gave them an overview of their services. She said that April is Sexual Assault Awareness Month.
