Commissioner Luthi moved to appoint Chris Lawson to the Ottawa County Zoning and Planning Board, effective January 14, 2019, to fill the vacancy from the resignation of Dawn Wolf. Commissioner Kay seconded. Motion carried, 3-0.

Truette McQueen, County Appraiser, visited with the commissioners about having his employees work some overtime in February and March, approximately 5 hours a week. The commissioners didn't have a problem with it a long as it is necessary.

John Pruitt, asked the commissioners their plan for Laramie Road. Commissioner Kay said part of the road is the City of Minneapolis. John discussed the portion of road to 135th Road, and 135th Road. John said that he would like the county to consider black topping 135th Road. The commissioners said that they have discussed the condition of the roads with the township board.
