On a motion by Commissioner Wolf, seconded by Commissioner Malmberg, by unanimous vote the Board approved the claims as presented.

Noxious Weed

Kenny Baccus came into the meeting and Malmberg let Baccus know that he will not be getting the longevity pay due to him leaving before the December 31st date.

Chis Smith, Joe Mullen and Shafer Nelson came into the meeting.

Noxious Weed/Road and Bridge

Smith and Baccus came to discuss a department update for the Noxious Weed and Road and Bridge department. Baccus would like to have an idea of how the departments will work moving forward so they can plan something before Baccus leaves next week. Mortimer said he would like to have Smith in charge and asked Smith to get his spraying license quickly. Malmberg said there will need to be position description updates. Malmberg would like to see the supervisor have a spray license and 2 additional people have spray licenses. The county would pay for the license. Commission said for responsibility and jobs they would like to have Smith and Mullen figure out where the responsibilities should fall and then Smith should come back to the commission and let them know changes in job descriptions with the Road and Bridge and Weed Department. Wolf said they will need to find someone for the vacancy. Commission would like to cross train employees with Road and Bridge and Noxious Weed. Smith said he doesn't think that it will work to cross train from Road and Bridge. Baccus said that he has called Mitchell County Weed Director to come help Nelson with end of year reports. Baccus said he will need to know an interim director so he can let the state knows who they need to be in contact with.

On motion by Commissioner Malmberg, seconded by Commissioner Wolf, by unanimous vote the Board approved Chris Smith as the Interim Noxious Weed Director.

On a motion by Commissioner Wolf seconded by Commissioner Malmberg, by unanimous vote the Board approved a 15-minute executive session for personnel exception to discuss non-elected including Wolf, Mortimer, Malmberg, Baccus and Smith. To return at 10:00am.

On motion by Commissioner Wolf, seconded by Commissioner Malmberg, by unanimous vote the Board approved to offer Kenny Baccus a one time consulting fee of \$1,560.00 for answering questions about Noxious Weed procedures through 2024. This will be paid on November 10th.

On motion by Commissioner Malmberg, seconded by Commissioner Wolf, by unanimous vote the Board approved to accept the Credit Card Policy, Policy number section 40-02.

Commissioner Wolf talked with Matt Pickrell with Ottawa County Farm Bureau about helping with the annual maintenance fees for the Mesonet system going forward. Wolf attended the Farm Buru board meeting on Wednesday night and the board discussed how they could find other sponsors to help with this. Commission will have a work session on Monday at 7:00am November 6th.

With no further business before the commission the meeting was adjourned at 10:34am on motion by Wolf and seconded by Malmberg. Motion carried by unanimous vote.
