Phil Aumick, Economic Development Director, touched base with the board on the tax abatement policy resolution. He asked if the commissioners have had a chance to look through everything he has given them. The commissioners need to set a base amount before the resolution can be done. Phil then discussed the comprehensive plan, and gave the commissioners some information that he would like for them to look over. Phil discussed electronic records for cemeteries with the board.

Shannon Luthi, Highway Administrator, reported on what crews were doing. Shannon said that he was going to have to pursue getting something done on the septic system at the shop.

Keith Coleman, Sheriff, gave prisoner count of Saline County 42, Sedgwick County 2, and Ottawa County 6. Keith said that they got the new washing machine in. He is still looking for one correction officer.
