Commissioner Brumbaugh opened the meeting in prayer and then led the group in the flag salute.

Mary Arganbright, County Clerk, gave the commissioners quotes for managed service monitoring for the courthouse, health department, and law enforcement center. Mary will set-up an appointment with Scott Hardin, Lockit, to come visit with the group about the different options. Mary gave the commissioners estimates for replacing the curtains in her office that have been up for 30+ years. She will get together with the other department heads and give them the information she got, and see what other offices wish to do.

Phil Aumick, Economic Development Director, gave the commissioners an update on what he has been doing.

Ralph Shank was an observer.

Shannon Luthi, Road & Bridge Administrator, gave the commissioners the Request to Exchange Federal Funds. Commissioner Luthi moved to approve the Request to Exchange Federal Funds under the Federal-Aid Fund Exchange Master Agreement. Commissioner Kay seconded. Motion carried, 3-0. Shannon reported on what crews were doing, and reported that he is interviewing today. Commissioner Luthi moved to go into executive session at 9:07 a.m. for five minutes to discuss non-elected personnel, to protect the privacy of the employee. Commissioner Kay seconded. Motion carried, 3-0. Those present were the commissioners, Shannon, and Mary Arganbright, County Clerk. They returned to regular session at 9:12 a.m. No decision was made. Shannon gave the commissioners the Ottawa County Solid Waste Hauler's Permit No. 036 for Minneapolis Refuse Service, and Ottawa County Solid Waste Hauler's Permit No. 038 for Salina Waste Systems. The commissioners approved and signed the permit.

Marie Ballou, Emergency Management Coordinator, visited with the commissioners about her overtime hours. The commissioners asked for clarification on her deployment time, and if she has to go. Marie explained the procedures to the board. Marie said that she knows that her salary line item is going to be over budget this year. The commissioners said for Marie to start leaving for out of town meetings during regular work hours, and that would cut out a little over time. Commissioner Brumbaugh will do some checking with other counties on how they handle some of the questions.

Keith Coleman, Sheriff, gave prisoner count of Saline County 46, KDOC 1, and Ottawa County 6. Keith said that he met with Archetype Design Group, LLC, last week, and the drawings were looked over for the law enforcement center remodeling project.

Matt Dixon, Custodian, brought in three estimates for the window pane replacements. Hopper's Glass, Wichita, \$19,790; Interstate Glass Co., Inc., Junction City, \$15,050; and Glass Services Inc., Salina, \$8,400. The total windows that are broken are 20. Commissioner Luthi moved to approve the proposal from Glass Services, Inc., to replace 20 windows for \$8,400. Commissioner Kay seconded. Motion carried, 3-0.
