The Board of Commissioners met in regular session with Commissioner James P. Kay, Commissioner Karen S. Brumbaugh, Commissioner Kathy M. Luthi, and County Clerk Mary Arganbright.

Commissioner Kay opened the meeting in prayer and then led the group in the flag salute.

Sara Hodges, and Amanda Loughridge, Health/Aging Department, met with the board and Sara discussed the Constitution and By-Laws of the Ottawa County Council on Aging. Sara said that the By-Laws have been given out to the Aging Council for review. Amanda gave the board a copy of the Ottawa County Transportation Title VI Plan Outline for review and approval. The commissioners will review the document and get back with her. Amanda said that it was due in December, and they are just getting around to submitting it for approval. Sara went over other programs they are doing.

Shannon Luthi, Highway Administrator, reported on what crews were doing. Shannon asked if the county ever hired part-time summer help. The commissioners said that they have in the past, but it's been a long time ago. Shannon asked if businesses were eligible to bring tires out on the tire clean-up program. Shannon updated the commissioners on the cell at the landfill that is retaining water.
