The Board of Commissioners met in regular session with First District Commissioner, Kathy M. Luthi, Second District Commissioner James P. Kay, Third District Commissioner Karen S. Brumbaugh, and County Clerk Mary Arganbright.

Pastor James Blake opened the meeting in prayer and then Commissioner Brumbaugh led the group in the flag salute.

Dawn Wolf, First District County Commissioner-Elect, was an observer.

Added's and abatements were approved.

Vouchers were approved.

Commissioner Kay moved to accept the resignation of Jim Struble as Concord Township Treasurer, effective 12/31/18. Commissioner Luthi seconded. Motion carried, 3-0. Commissioner Kay moved to appoint Sharon Flegler as Concord Township Treasurer, effective 1/1/19. Commissioner Luthi seconded. Motion carried, 3-0.

Tommy Barrett, and Albert Slater, Lincoln Township Board Members, discussed roads in Lincoln Township. He also went through the process the township board does to review the roads, how they keep track of material that gets put on the roads, etc. Shannon Luthi, Road & Bridge Administrator, joined the group. Albert gave the commissioners pictures and documentation on issues. Albert said that they have \$18,000 of rock that has been covered up with dirt by the county maintainers. Albert said that the county owns the roads, but the township owns the rock. He asked if the county was going to replace the rock? Shannon asked about the list that the township gave the Road Foreman at the first of the year, and how much has got done. Albert said that 1 tube has got replaced on Ottawa Rd and 280th Rd. There are 4 to 5 tubes on various other roads that need replaced. Albert said that they need help, and need the rock replaced.

David Johnson asked the commissioners the status of the bridge project on 170th Road. Steel quote in September was \$74,000 and concrete would be \$5,000. Commissioner Luthi moved to put the bridge on 170th Road into the 2019 budget to replace the bridge. Commissioner Kay seconded. Motion carried, 3-0. Shannon Luthi, Road & Bridge Administrator, gave the commissioners quotes for a 2018 rotary mower. Barry Blake, LDI, and Wally Waltner, Rhino, were present. LDI, \$16,900; Concordia Tractor, \$16,600; Carrico Implement for \$17,937, and Lott Implement, \$16,000. Commissioner Kay moved to purchase the Land Pride rotary mower RCM6610 for \$16,000, from Lott Implement. Commissioner Luthi seconded. Motion carried, 3-0. Shannon gave the board a quote from Professional Cleaning Systems, for a Landa ENG4-30024A Natural gas heated pressure Washer, 3000 PSI, for \$6,175, or a Landa ENG4-22024A, 2200 PSI, for \$5,795. Commissioner Kay asked for another quote from another company. Allen Brown, Road Foreman, joined the group, and the Lincoln Township road issue was discussed. It was decided the commissioners would go look at the roads as a group, next week. Commissioner Kay moved to go into executive session at 9:56 a.m. for non-elected personnel, to protect the privacy of the employee. Commissioner Luthi seconded. Motion carried, 3-0. Those present were the commissioners and Shannon Luthi, Road & Bridge Administrator. They returned to regular session at 10:01 a.m. No decision was made.
