Commissioner Brumbaugh moved to approve application 29 for S Scott Wallace & Julie A Nelson; application 30 for Kent and Suzy Crosson; application 31 for Wanda Penn; and application 32 for Anthony and Maureen Cataldo. Commissioner Luthi seconded. Motion carried, 3-0. Commissioner Brumbaugh moved to go into executive session at 9:11 a.m. for fifteen minutes to discuss non-elected personnel, to protect the privacy of the employee. Those present were the commissioners, Shannon, and Mary Arganbright, Ottawa County Clerk. They returned to regular session at 9:26 a.m. The commissioners will take Shannon's recommendation to move Chris Smith to the vacant foreman position, effective November 25, 2017, with a pay increase of \$1.20, to \$17.50 per hour.

David Crosson, stopped in and visited with the commissioners about the Sunset Road hearing the commissioners held last week, and their decision to deny the request to open the road. David said that there are people that are interested in that road being open, and explained reasons why he thought the road should have been opened. David will visit with Jim Klein, Sheridan Township Clerk, and come back and meet with the commissioners.
