Emergency Management

Marie Ballou, Emergency Management, and Shelby Walker, Deputy Clerk came into the meeting to talk with the commissioners about a homeland security inventory system. Ballou said this system will enable the county to tag items that is Ottawa County property has. Malmberg asked what this system would cost. Ballou said that there is no cost, Homeland Security has grants for counties to allow them to do this for free. Mortimer asked what this would look like for other departments. It was agreed upon that the inventory would be a great idea for the individual departments. The commission would like to have Road and Bridge get on the agenda with Ballou and Walker to discuss it more in detail.

Sheriff

Prisoner count for Ottawa County 5, and Saline County 29, for a total of 34.

Taylor Haws, with Central Kansas Mental Health Center came into the meeting and read the Mental Health Proclamation. Haws is asking the commission to declare May as Mental Health Month. On motion by Commissioner Malmberg, seconded by Commissioner Mortimer, by unanimous vote the Board approved to make the month of May Mental Health month in Ottawa County.

Clerk

Heather Maddox, County Clerk discussed with the commission what she found out with the voting equipment. Maddox discussed it would be beneficial to purchase voting equipment this year due to annual software updates. Maddox said that if we purchase new equipment, we could get one election under our belts before we have 3 next year. We could take this time to train poll workers now instead of in the rush of the elections next year. Maddox gave commissioners a bid for new voting tablets, new poll pads and new scanners.

On motion by Commissioner Malmberg, seconded by Commissioner Mortimer, by unanimous vote the Board approved new voting machines and poll books in the amount of \$39,192 to be taken out of ARPA Funds and the remaining \$30,000 will come from the Election Capital Outlay.

On motion by Commissioner Malmberg, seconded by Commissioner Mortimer, by unanimous vote the Board approved to adopt Resolution 23-11 for pay raises starting April 25th.

Brandon Baugh came into the commissioners meeting to present the Tescott Fire Department budget. Baugh talked with the commission about fundraising the department did last year, they put on a ranch rodeo, and it was very successful.

On a motion by Commissioner Malmberg seconded by Commissioner Mortimer, by unanimous vote the Board approved a 30-minute executive session for negotiations to discuss employment including, Mortimer, Malmberg, and by phone Michelle Campbell. To return at 11:25am.

On motion by Commissioner Mortimer, seconded by Commissioner Malmberg, by unanimous vote the Board approved to hire Michelle Campbell as HR Coordinator, Payroll Clerk, and IT.

On motion by Commissioner Mortimer, seconded by Commissioner Malmberg, by unanimous vote the Board approved to recess until 1:00pm.
