Noxious Weed

Kenny Baccus, Noxious Weed Administrator presented to the commission chemical bids. On motion by Commissioner Malmberg, seconded by Commissioner Wolf, by unanimous vote the Board approved chemical purchases as discussed.

Road and Bridge

Chris Smith Road and Bridge Administrator, and Joe Mullen, Road Supervisor, brought the commission a list of equipment that they would need for the Road and Bridge department. Smith talked about how a few trucks aren't in good shape. Mortimer discussed how the road and bridge budget got cut 50k last year and 100k the year before, maybe they could use ARPA funds to help upgrade trucks with it. Smith discussed selling trailers and trucks to help with the cost selling 3 dump trucks, 3 pups, and a semi. They will replace 1 semi and 2 dump trucks.

Emergency Management

Marie Ballou, Emergency Management Director, brought up the County Emergency Operations Plan for the commission to sign.

Smith continued with an update from Phil Balch with Wildhorse Riverworks, Inc. about the river erosion on Rifle Rd and Frontier Rd. Commission asked Smith to get ahold of Kirkham Michael to see if they would be willing to sign off on the design from Balch. Smith will send the information over and get back with the commission.

Sheriff

Prisoner count for Ottawa County 5, Saline County 23, Sedgwick 22, for a total of 50. Commission discussed putting a Human Resources ad out. Commission wrote up an ad and a job description for the HR position.

On motion by Commissioner Malmberg, seconded by Commissioner Wolf, by unanimous vote the Board approved a longevity bonus for part time employees working over 1040 hours a \$0.05 an hour per year at 1040 hours to be paid in one lump sum on the November paycheck, with a cap at 15 years.

On motion by Commissioner Malmberg, seconded by Commissioner Wolf, by unanimous vote the Board approved a longevity bonus for full time employees at \$0.05 an hour per year for 2080 hours to be paid in one lump sum on the November paycheck, with a cap at 15 years.

With no further business before the commission the meeting was adjourned at 11:48pm on motion by Wolf and seconded by Malmberg. Motion carried by unanimous vote.
