Fire Departments cash transfers and unencumbered cash were also discussed. We handle some fire districts different than others regarding paying bills. This needs to be researched and discussed at a future meeting.

JoDee Copple will post the job on the Facebook page and on the website.

It was decided that Jennifer Guipre and Kathy Luthi will work together to balance 2021 payroll accounts and complete the year end reports. Jeff Reece, auditor will let us know what their firm can do to assist.
