5. EMS Grant

Tony Swetson, Bennington EMS, presented a grant in partnership with Minneapolis EMS that was awarded through a three-year, \$300,000 grant for a mobile integrated health program. The program focuses on providing services that traditional home health care cannot, targeting homebound individuals or those with mobility challenges. Services include diabetes management, wound care, post-surgery checkups, COPD and emphysema support, fall assessments, and connecting patients to local resources. The initiative aims to reduce repeat ER visits by filling gaps in care and helping patients remain at home. Two vehicles funded by the grant will operate in Minneapolis and Bennington, and the program will rely on telehealth and referrals from Federally Qualified Health Centers (FQHCs), which handle billing. While the program hopes to become self-sustaining, it will cease if no further funding or legislative support materializes after three years. Tony Swetson emphasized the significant need for this program, which also collaborates with Salina and Ottawa County facilities, and the Ottawa County Health Department.

6. Ottawa County Council on Aging Appointments

Sarah Hodges, Health Department Director, presented the Ottawa County Council on Aging board appointments for 2025. There is only one change from last year. The appointments are:

Sarah Hodges stated each center nominates their representative. The Commission discussed using someone who works locally for the department medical consultant. Commissioner Malmberg stated she lives in Ottawa County she is fine with her being the consultant. Sarah Hodges stated the clinic runs underneath the doctor's license; medical consultants are hard to find. The job pays \$100.00 per month.

7. Medical Director for Minneapolis EMS

Karl Leech, Minneapolis EMS Director, stated they will be getting a new medical director on January 01, 2025. The new medical director will be Dr. Herrington. Dr Herrington is already the medical director for Bennington and EMS and is the head of the ER at Salina Regional. He is also the director for Lincoln and Salina EMS. The medical director looks over protocols and answers any questions EMS may have.

8. Solid Waste Exemption Discussion

JoDee Copple, County Treasurer, discussed solid waste exemptions. She asked the Commission if they would like to have a staff recommendation from the Appraiser's office. Commissioner Wolf stated if it is in a Commissioner's district they will go look at it. The Appraiser's officed does an annual review of properties. The Commission discussed criteria including whether there was water and electricity, if it was livable which means the location could generate trash. It was the consensus of the Commission to have a staff recommendation. JoDee Copple asked if there should be an expiration date on the exemptions. Commissioner Wolf stated it should not be an automatic renewal. Commissioner Mortimer suggested every four years. JoDee Copple asked if the exemptions granted would apply for 2024; the consensus of the Commission was yes.

9. Kimble Mapping Contract

Tammi Cox, County Clerk, presented the 2025 Kimble Mapping Contract for GIS map maintenance. The total fee is \$12,000.00.
